Information Collection And Use

Log Data

Like many site operators, we collect information that your browser sends whenever you visit our Site ("Log Data").

This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics.

In addition, we may use third party services such as Google Analytics that collect, monitor and analyse this to further refine our advertising and make sure it appears only to the appropriate audiences or users already in contact with our corporation.

The Log Data section is for businesses that use analytics or tracking services in websites or apps, like Google Analytics and facebook Pixel.

Communications

We may use your Personal Information to contact you with newsletters, marketing or promotional materials and other information.

The Communications section is for businesses that may contact users via email (email newsletters) or other methods. Only approved businesses may contact you and only with your approval. We wil contact you to ask for your permission in this scenario.

Cookies

Cookies are files with small amount of data, which may include an anonymous unique identifier. Cookies are sent to your browser from a web site and stored on your computer's hard drive.

Like many sites, we use "cookies" to collect information. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Site.
